
Goodbye and good riddance 2020. Welcome 2021!



NMERB Update

New Mexico Education Retirement Board (NMERB) has been underfunded for several years and steps have, and are being taken to alleviate the problems, however, current projections show the NMERB becoming insolvent in 100 years.

Current steps to prevent insolvency:

- Raised retire eligibility to 30 years of service (was 25)
 - o Age plus years of service to equal 80 instead of 75
 - Reduced benefits if retiree has service less than 80
- Cost-of-living (COLA) increased reduced until NMERB reaches 90% funded
 - No COLA until retiree reaches 65 years of age
- Anti-spiking provisions (for salaries over \$60,000, the portion over 130% of prior year will be ignored for retirement calculations) enacted, effective 7/1/2019
- Graduated multipliers to reduce harm to "fund" by short career members (used to calculate retirement benefit)

2021 Legislative proposal

Year 1: Increase **employer** contribution by 1% (to 15.15%) Year 2: Increase **employer** contribution by 1% (to 16.15%) Year 3: Increase **employer** contribution by 1% (to 17.15%) Year 4: Increase **employer** contribution by 1% (to 18.15%)

Each 1% increase in contributions will increase contributions by about \$30Million and bringin the funded ration (anticipated) to 73.6% by 2051.

None of these steps will have an immediate effect on current retirees.

Thanks to Chuck Culpepper for summarizing a <u>13-page document</u> from the NMERB into a more succinct and sensible document (above). I had difficulty formatting it into this YARN. COVID-19 Vaccination Registration

The New Mexico Department of Health has set up an online registration process whereupon citizens can register for a free COVID-19 vaccination, should they decide to do so. The site is user friendly, and once the citizen's profile is registered, they will be notified when a vaccine is available for them. According to the January 6 edition of the Santa Fe New Mexican, 300,000 people have registered already, and an estimated 62,000 to 68,000 people have been vaccinated already. Where changes were made, the **OLD** version (or explanation of the old version) is printed in parenthesis, italics, and underlined so you can see how the old version compares to the new version. Members may address any concerns at the January 12th Zoom meeting, which will then be discussed, with final voting taking place at the meeting. Adoption of the new Constitution and Bylaws will be determined by a majority vote at the January 12th Zoom meeting. Thank you for participating.

San Juan Association of Educational Retirees CONSTITUTION January 2021

PREAMBLE

We, the members of the San Juan Association of Educational Retirees, in order that the Association may serve as the voice for educational retirees and work for the benefit of retired members to preserve and improve their economic and health care benefits, monitor legislation regarding retirement issues, ("provide training designed to ensure participation on pension boards" was deleted) develop social activities and programs ("programs" replaces the word "seminars") consistent with retirees' interests, work for the advancement of education and the improvement of instructional opportunities for all, support educational issues for the benefit of active and retired members, function as a representative body to speak with authority for the members, establish cooperation with the educational community including its affiliates, do hereby adopt this Constitution.

ARTICLE I. NAME, GOALS, AND OBJECTIVES, GOVERNANCE, AND AFFILIATION

Section 1. Name. The name of this organization shall be the San Juan Association of Educational Retirees; hereafter referred to as SJAER or "the Association".

Section 2. Goals and Objectives. The goals of SJAER shall be as stated in the Preamble. The Association shall have all power necessary and proper to take action for the attainment of these goals. Nothing in this constitution or in the Bylaws shall be construed to prevent the Association from pursuing objectives which are consistent with the stated goals of the Association.

Section 3. Governance. The SJAER shall be governed by this Constitution, the Bylaws, <u>("the Standing Rules" was deleted)</u> and such other actions as its membership or Executive Committee may take consistent therewith.

Section 4. Affiliation. The SJAER shall be an affiliate of the New Mexico Association of Educational Retirees and the National Retired Teachers Association, a division of AARP.

ARTICLE II. MEMBERSHIP

Membership shall be open to any person who was/is employed in a school, college, university, educational institution or agency upon payment of the SJAER annual dues. Each member shall have equal rights and privileges within the organization, including but not limited to the right to vote and to hold elective/appointive positions. The non-educator spouse of a member may become a member upon payment of the SJAER annual dues, but will not be eligible to hold an elective office.

ARTICLE III. EXECUTIVE OFFICERS

Section 1. Executive Officers. The Executive Officers shall consist of President, ("President-Elect" was deleted) Immediate Past President, Vice President, Secretary, Treasurer, and Assistant Treasurer.

Section 2. Standing Committees. The Standing Committees shall consist of Program, Membership, Legislative, Publicity, Telephone, Courtesy, Social, and Scholarship. <u>(Insurance, Pre-Retirement, and Newsletter Committees were deleted. Note: the YARN newsletter is proposed to be part of the Publicity Committee.)</u>

Section 3. Election of Officers. The elected officers of the Association shall serve for terms of one year and may be reelected.

ARTICLE IV. RULES AND REGULATIONS

The Constitution shall govern the Association in all cases to which they are applicable and in which they are not inconsistent with the Bylaws of this Association. (Here is the complete old version: "The rules contained in the 'The New Robert's Rules of Order Current Edition' shall govern the Association in all cases to which they are applicable and in which they are not inconsistent with the rules of order or the By-Laws of the Association.")

ARTICLE V. AMENDMENTS

The Constitution may be amended by a majority of the members voting at a meeting, provided such proposed amendment(s) have been presented to the membership in printed form in the YARN at the preceding monthly meeting.

San Juan Association of Educational Retirees BYLAWS January 2021

ARTICLE 1 – MEMBERSHIP DUES

- 1.1 The SJAER annual dues rate can be changed by recommendation of the Executive Committee, with the approval of the membership.
- 1.2 Annual membership dues may be paid by cash or by personal check.

ARTICLE II – FISCAL YEAR

The fiscal year of the Association shall begin January 1 of each year and end December 31 of each year.

ARTICLE III - TERMS OF ELECTED OFFICERS

Terms of elected officers shall begin and end in May, after officers are installed. (Replaces: "Terms of elected officers shall begin on July 1 and end June 30 of each calendar year.")

ARTICLE IV - EXECUTIVE OFFICERS

4.1 Powers and Duties of the President.

The President shall represent the Association as its official voice to the members and to the public. In addition, the President shall be responsible for: developing and overseeing the budget, presiding over regular and special meetings, developing the agenda for regular and special meetings, appointing committee members, regular and ad hoc, with the approval of the Executive Committee, serving ex officio on all committees, leading and assisting in the promotion of the Association, performing other duties as agreed upon with the Executive Committee. (In Article III, Section 1 of the Constitution, it is proposed to delete the Office of President Elect. The old version stated its powers and duties were: "The President Elect shall perform such duties as directed by the President and the Executive Committee.")

4.2 Powers and Duties of the Immediate Past President

The Immediate Past President shall perform duties for the Association on request of the President and the Executive Committee.

4.3 Powers and Duties of the Vice President

The Vice Past (Editor Note: 1 think the word "Past" here is a typo and should be deleted.) President shall perform duties as directed by the President and the Executive Committee.

4.4 Powers and Duties of the Secretary

The Secretary shall have the primary duty of keeping the minutes and records of the meetings of the Executive Committee and regular meetings. Additional duties shall be those agreed upon with the President and the Executive Committee.

4.5 Powers and Duties of the Treasurer

The Treasurer shall provide a detailed report of budget receipts and expenditures to the Executive Committee and the membership. The Treasurer shall present the books for audit at the end of the fiscal period. An Audit Committee shall be appointed by the President at the January meeting. The committee shall make its report at the April meeting. The Treasurer shall perform other duties as assigned.

4.6 Powers and Duties of the Assistant Treasurer

The Assistant Treasurer shall assist the Treasurer in all duties as specified above. The Assistant Treasurer shall perform other duties as assigned.

4.7 Executive Committee Quorum

A quorum shall be a majority of the Executive Committee.

ARTICLE V – STANDING COMMITTEES AND THEIR DUTIES

Standing committees shall be established to meet program goals for the Association and to ensure participation and representation from the membership at large.

5.1 Duties of the Program Committee

The Program Committee shall secure program presenters for each monthly meeting.

5.2 Duties of the Membership Committee

The Membership Committee shall be responsible for the renewal and recruitment of members. The Pre-Retirement representative shall prepare and deliver information about SJAER to educational institutions in our area. *(The last*

sentence here is an addition; it was not in the old version. It was added here because in the old Constitution, Article III, Section 2, the Pre-Retirement Committee is being proposed to be deleted so its duties are being incorporated into the Membership Committee here.)

5.3 Duties of the Legislative Committee

The Legislative Committee shall be responsible for lobbying legislators and informing members of pending bills at the state level that may affect our retirement, health care, or be of interest for the well-being of our members. (Replaces this old version: "The Legislative Committee shall be responsible for developing and recommending the legislative agenda, for informing members of pending bills, and for lobbying legislators.")

5.4 Duties of the Publicity Committee

The Publicity Committee shall make reports provided by the Executive Board and Standing Committees available to the members. THE YARN representative will prepare the newsletter, send it to the website representative, and distribute it at monthly meetings. The Website representative will post THE YARN and other information that supports our association on the SJAER website. (Replaces this old version: "The Publicity Committee shall be responsible for notification of meetings through the local media.")

5.5 Duties of the Telephone Committee

The Telephone Committee shall be responsible for calling members who do not have an e-mail address or who indicated to be called on their registration form. They will relay meeting reminders and important issues of concern. (Replaces this old version: "The Telephone Committee shall be responsible for calling membership for meeting reminders and important issues of concern to the membership.")

5.6 **Duties of the Courtesy Committee**

The Courtesy/Sunshine Committee shall send cards to members who are ill or bereaved. The Courtesy/ "In Memoriam" shall submit names of members who have passed to the Yarn and the state. (Replaces this old version: "The Courtesy Committee shall send cards to members who are ill or bereaved."). (Editor Note: Re-word 2nd sentence for grammar? The Courtesy/In Memoriam Committee shall submit names of deceased members to the YARN and to the State.)

5.7 Duties of the Social Committee

The Social Committee shall be responsible of social functions at general membership meetings and other social activities.

5.8 Duties of the Scholarship Committee

The Scholarship Committee shall promote and oversee the SJAER Scholarship Fund. (Deleted: "at San Juan College") (Note: In the old version of the Constitution, Article III, Section 2, it listed the Newsletter Committee, the Insurance Committee, and the Pre-Retirement Committee, all of which the recent ad hoc Constitution Review Committee proposes to delete. Duties of these committees as stated in the old version of the Constitution are as follows: "The Newsletter Committee shall prepare and distribute THE YARN at the monthly meetings. The Committee shall also prepare and distribute the Yearbook." "The Insurance Committee shall monitor and report current information and changes relative the Retiree Health Care Authority." "The Pre-Retirement Committee shall prepare and deliver pre-retirement information.")

ARTICLE VI - ELECTION

- 6.1 The President shall select a nominating committee by the January meeting which shall present a slate of officers to the membership at the regular meeting in March. Nominations from the floor shall be accepted if the nominee has agreed to serve.
- 6.2 Voting shall be by a show of hands at the March meeting.
- 6.3 Officers shall be installed and take office in May.
- 6.4 Vacancies shall be filled by appointment of the President and with the approval of the Executive Committee.

ARTICLE VII – FISCAL ACCOUNTABILITY

- 7.1 An annual audit shall be conducted by an appointed committee after the close of the fiscal year.
- 7.2 No expenditure shall be made by an association officer unless it is within the scope of the budget or has been approved by the Executive Committee.

ARTICLE VIII – AMENDMENTS

These Bylaws may be amended by a majority vote, <u>("by a majority vote" replaces the old version: "by a majority of the members voting at a meeting")</u> provided such proposed amendment(s) have been presented to the membership in printed form in THE YARN at the preceding meeting. The Bylaws shall be reviewed every five years.

ARTICLE IX - MEETINGS

Regular meetings of the membership shall be held September through May on the second Tuesday of each month at 11:30 a.m. at a place designated by the president. (*The End*)


