A LETTER FROM THE PRESIDENT

December 2021

IN THE SPIRIT OF GIVING, OR WHY I GIVE!

Today as I left the Safeway parking lot, there was a young woman sitting on the curb with a cardboard sign: HUNGRY. I gave her a \$5 bill through my passenger side window. She was grateful and said "Thank you" several times.

As I drove around the corner to Main Street, I spotted two women also sitting on the curb. Their sign read "Anything." I dug in my pocket and came up with another \$5 bill and handed it off to those women and got two big smiles and another chorus of thank you.

The reason I had five dollars handy was because I had recently read an article by a man who always kept a \$5 bill in his pocket in case he ran across a homeless person or someone down on their luck. He argued that in his community "\$5 wouldn't buy a bottle of booze but could provide a hamburger and drink." He said for him, it was the "right thing to do."

I liked the \$5 idea and put one in the cup holder in my car. Now I always have one there.

Giving those two "offerings" of \$5 made me feel good, because I can afford it and never want to be one who has to sit on the street corner "begging" (humbling/embarrassing myself) for help with money for food. Who am I to judge another's circumstances, or have requirements for how that money may be used. It is a "gift." Growing up my mom and I never really had much money, but I didn't think we were "poor." We ate a lot of "breakfast for dinner" (cereal and milk, often with or without fruit.) Fried slices of SPAM were a special treat! In college, I had no money beyond tuition and took advantage the USDA Commodity Program. Five pounds each of butter and cheese, along with a 5-pound bag of flour. That led me to apply for Food Stamps which led to better food choices...and lots of judgemental/disgusted looks from the check-out clerks.

After graduation, I moved to a small town in Colorado. I had the luck to find a job, between teaching gigs, with the Department of Social Services and worked with LEAP Program providing assistance for low-income families to pay for their winter heating bills. I shared an office with several DSS employees and I was embarrassed to hear the frequent negative comments from the Social Workers about their clients on food stamps and the items they were seen buying in the only grocery store in town. "I couldn't believe it when Sue Smith bought a huge steak with her food stamps!" "Frank Jones bought a double layer cake!" "You should have seen the amount of prepared Deli foods John and Mary Gibson bought." After hearing these kinds of comments more than once, I finally spoke up, "What if Sue and her family were celebrating a big event and a steak was a way to feel like they were really lucky. Buying a cake to celebrate someone's birthday or anniversary is a common thing to do. Buying prepared foods might indicate the Gibson's stove or refrigerator is broken and they have no way to cook or save food right now." The office was quiet after that whenever I was doing paperwork there, so I just kept my head down and prayed for school to start up again so I could deal with teenagers and not adults!

It is easy to judge another person's actions, but do we have a right to do it without regard for the circumstances that create that behavior? Something to think about.

Now go ahead and put a \$5 bill in your pocket or purse, or the cup holder in your car.

For all our many blessings, may we be thankful!

SAN JUAN REGIONAL MEDICAL CENTER CORPORATION QUARTERLY REPORT – OCTOBER 2021

The Corporation cancelled it's in-person meeting this quarter due to the pandemic. Instead, a print report was sent to all member organizations. A few items of Hospital news follow:

*As part of a comprehensive neurosciences program, a Physiatry Clinic is now open at 735 West Animas. Dr. Carletta Thompson and Nurse Practitioner LaPrincess Tso are now seeing patients. A "physiatrist" is a physician who specializes in Physical Medicine and Rehabilitation. Dr Thompson will diagnos, manage and treat pain from injury, illness or medical conditions predominantly using physical means of recovery such as physical therapy and medicine.

*AirCare has purchased a new fixed wing airplane for emergency transport. The Pilatus PC-12 NGX. The new plane has the latest technology, including enhanced safety aids for the crew and improved safety, comfort and quiet for patients. AirCare continues work to provide safe emergency medical flights to our community.

*Leaders of the City of Farmington and San Juan County visited SJRMC (twice) to honor caregivers for the hard work, commitment, and dedication they've demonstrated during the COVID-19 Pandemic.

*A Labyrinth was installed in the Healing Garden to honor the lives of caregivers who passed away during the pandemic. Walking a labyrinth facilitates healing, promotes health and encourages reflective meditation.

*Financially, the hospital is still demonstrating stability even though COVID-19 continues to drive up expenses. The CARES Act provided \$42.0M of relief in offset over the past 22 months and the hospital continues to look state and federal assistance opportunities for funding.
