


## **New Message about Volunteering**

#### Meeting was called to order by Jim Conyers.

Agenda and previous meetings minutes were approved.

#### **New Business**

- > Scam reported by Jim Conyers: Jim asked the state to post our email information on the state website and then Kathy received a request for gift cards. The state office confirmed it was a scam that has been around for several years. Jim asked that the email addresses be removed from both state and local websites.
- > Schedule May Picnic Location: The Board decided that Civitan and Kiwanis Parks are good locations because they are centrally located and easy to find. Debbie volunteered to contact the City to see which parks might be available and schedule one for the picnic.
- ➤ **President's meeting in March:** Jim Conyers will be attending. He believes the state organization will pay for everything so at this time, Jim will not be requesting any money.

#### **Old Business**

- ➤ Officers for 2024-2025: Connie Alley has requested that a new secretary be elected. Marilyn Montoya will work on getting a slate of officers.
- ➤ IRS Issues: Kathy Martin presented the letter with our EIN number and our Constitution and Bylaws which were revised in January of 2021. Debbie Klein reported that she spoke with Russell Goff at the state agency to see if our unit is under the state IRS umbrella. Russell stated that each unit is on its own and need to file with the IRS each year, It was discovered that we may or may not have applied for 501c3. It was thought that either Harold Clark, CPA, or Tom Stampler of Alpha and Omega Accounting filed the paperwork. Debbie volunteered to continue investigating the IRS issue.
  - o **A break was taken to order lunch**. Karen ordered the sampler plate, Sandy ordered nachos, Kathy ordered taquitos, Debbie ordered ½ Alburquerque Turkey, etc. Discussion occurred concerting the buffalo wings. Jim brought us back to the meeting. •
- Audits: Discussion ensued on how to do our audits. Debbie Klein suggested a simple process of having someone on the board review the statements and checkbook at each meeting to confirm their accuracy. It was decided that we would do that and see if there is a need for a more formal audit once a year.

## **Committee Reports**

- ➤ **Treasurer report:** Kathy Martin reported a balance of \$2653.80. She hasn't deducted the payments for the YARN for the past two months: Scholarship fund is \$260.00.
- **Membership:** No new members.
- **Sunshine:** Nancy apologized for not sending Phyllis a card for her eye surgery, but she telephoned her.
- ➤ **Programs:** Debbie, Karen, Marilyn, and Phyllis have secured speakers for the rest of the year and probably have September and October scheduled as well. Today's speaker will be Rebecca Morgan speaking about the Ukrainian Families being sponsored by the Gordon Glass Sponsorship Circle. Programs are listed in the YARN.
- **Legislation/Website:** The latest Legislation update from Russell Goff is in the YARN.
- **YARN:** Debbie reported that she included both hospital corporation reports.
- > **SJRH:** Jim and Karen attended their meeting. Their reports are printed in the YARN.
- ➤ In Memoriam & Volunteer Hours: Ruben Gonzales passed away. Both he and his wife were members. Trish Murphy had nothing extra to report.
- $\triangleright$  Scholarship: We have  $\frac{1}{2}$  of what we need for another scholarship. Split the pot continues.

#### **NEW MEXICO AER - FINAL LEGISLATIVE UPDATE**

As the second session of the 58th Legislative Session came to a close at noon on Thursday, February 15th, we saw an accumulation of 658 bills that were introduced over the session. Of those 658 pieces of legislation introduced, 45 bills, memorials, resolutions, and joint resolutions passed in the Senate and 62 passed in the House. Three bills currently have been signed by the Governor:

- 1) HB 1, Feed Bill for the legislative session.
- 2) HB 141, Supreme Court Salary Increases Judges' salaries to \$232,600.
- 3) **HB 171, School Graduation Requirements** will provide for more student choices including a class in financial literacy. These changes go into effect in the 2025-26 school year. The remaining bills have been sent to the Governor for her signature.

# HERE IS SOME OF THE KEY LEGISLATION THAT PASSED BOTH CHAMBERS DURING THIS SESSION AND AWAIT THE GOVERNORS SIGNATURE. THE GOVERNOR HAS UNTIL MARCH 6TH TO SIGN OR THE LEGISLATION BECOMES "POCKET VETOED":

- > HB 129, Firearm Sales Waiting Period would require a seven-day waiting period prior to purchasing a gun.
- > HB 207, Public School Outlay Grant would provide assistance to charter schools from public school capital outlay funds.
- > HB 252, Adjust Income Tax Brackets. This new tax package includes clean energy credits and reduces the income tax brackets.
- > HB 2 & 3, General Appropriations Act of 2024 provides a \$10.1 million budget for the year 2025. It also provides a 3% increase for public school employees.
- > SB 14, New Health Care Authority provides the framework for the new Health Care Authority including the Retiree Health Care Authority.
- > SB 15, Health Care Consolidation Oversight Act. This bill enacts the Health Care Consolidation Oversight Act and it reviews the proposed Health Care mergers.
- > **SB 117, School Board Training** provides for a requirement of 10 hours of training for School Board Members in ethics, school personnel, finance, governance, and others.
- > SB 153, Early Childhood Transfers increases the distribution of earlychildhood education funding by \$15 million.
- > SB 159, Higher Education Trust Fund creates a trust fund to provide tuition and financial aid for every NM higher education institution.
- > SB 165, Legislative Retirement Changes provide an increased pension for future legislative retirees.

#### **RETIREMENT:**

- > HM 1, Study Pension Benefit Structure, sponsored by Rep. Joy Garratt. This House Memorial proposes a study on equalizing the Pension Benefit structures of the Educational Retirement Board and the Public Employees Retirement Association. HM 1 died on the House floor.
- > SM 4, PERA & ERB Pension Benefit Structure, sponsored by Sen. Mimi Stewart. This Senate Memorial requests the LFC to study equalizing the Pension Benefit structures of the ERB and the PERA. SM 4 died on the Senate floor.
- > HB 222, Educational Retirement Returning to Work, sponsored by Rep. Jason Harper & Rep. Raymundo Lara. This bill raises the salary cap on earnings for some retired workers who return to work. HB 222 died in the House Education Committee.

#### **HEALTH CARE:**

> SJR 5, Public Employees Retiree Health Care Fund, sponsored by Sen. Roberto Gonzales. This Senate Joint Resolution would amend Article 20 of the Constitution of NM to prohibit the expenditure of the trust fund except for the benefit of the Trust beneficiaries. RHCA currently has a \$1.3 billion trust fund to assist retirees with the cost of their health care. This Joint Resolution failed on the Senate floor on a 25-14 vote. During the debate many issues surfaced; however, it was apparent there was strong opposition.

#### **EDUCATION:**

> HB 74, School Board Determine Instructional Day, sponsored by Rep. Gail Armstrong, Rep. Brian Baca, & Rep. Harlan Vincent. The Governor has recommended 180 School days. This bill proposes to allow the School Boards to make the decision on how many School Days. HB 74 was not heard and died in the House Rules Committee.

#### **BILLS OF INTEREST:**

- > HJR 1, Session, Length, Subjects, & Overrides, sponsored by Rep. Matthew McQueen, Rep. Greg Nibert, & Rep. Jason Harper. This House Joint Resolution proposes an amendment to Article 4, Section 5 of the Constitution of NM to provide that each regular session of the Legislature does not exceed forty-five days. HJR 1 died on the House floor.
- > HJR 2, Eliminate Pocket Veto, sponsored by Rep. Matthew McQueen. This House Joint Resolution proposes that an amendment to Article 4, Section 22 of the Constitution of NM provide that all bills passed by the legislature and not signed by the Governor will become law. HJR 2 died on the House floor.
